### Liton/Ghani Case 2009-15

Denise Warren presented maps to board. Discussion on pump sizes, number and location. Larry Cooke, Code Enforcement Officer offered some comments. After this meeting an engineer has to present a formal plan to DEC and DOT. Checklist for site plan given to surveyor.

Proposed- three thousand gallon super gas tank Three thousand diesel fuel tank Twelve thousand gallon regular gas

#### Discussion-

Property size limitations were discussed. Ms. Warren asked how to proceed. Mr. Wickes stated the property is small and concern is distance to building. He stated he could not approve or disapprove anything. DOT and DEC have involvement.

Mentioned was RT. 32 was a state highway and a three rod road. Larry Cooke had spoken with Steve Sheppard and this has to be forwarded to DEC. If sewerage is changed that is controlled by the Department of Health.

A complete plan needs to be submitted to the Greenville Planning Board. In that full site plan is the detailed plan and a new application is needed as size of tanks have been changed.

Larry Cooke added SEQR form has to be sent to the state for #'s 1-10 and then it gets sent back to Greenville.

Brian Wickes stated a full site plan and detailed map with contours is needed. How will 100' long trucks get in and other traffic?

Ms. Warren can meet with Larry Cooke, Steve Sheppard, and Don Teator. She will call parties to set this up.

Ms. Warren asked to see Stewart's gas station plans. Secretary to find these plans.

Mr. Fusario asked about the previous gas station. Larry Cook mentioned the high cost for environmental insurance and suggested the party look into the cost of this coverage.
