A public hearing was held by the Town Board of the Town of Greenville on Monday, October 15, 2018 at 6:00 pm in Pioneer Town Hall, to consider recommendations made by the Solar Zoning Review Committee and to receive public comment on the same.

Supervisor Macko opened the meeting with the Pledge of Allegiance. Appropriate notice of this hearing was published in an official newspaper, the Catskill Daily Mail, on Friday, October 5, 2018, and posted on the official signboard at Town Hall as required.

Mr. Bear moved, seconded by Mr. Richards, to open this public hearing at 6:00 pm. Carried 4 ayes

Supervisor Macko thanked the Solar Committee members for their review of our existing solar zoning law, and noted the time and diligence which was displayed in that process. The Committee's draft was presented to the Town Board at a meeting on October 1, 2018. Mr. Macko reviewed the proposed plan provided by the Committee, and the recommended changes the Town Board feels are necessary.

Ms. Barbara Valicenti stated she was concerned with changes that were made by the Town Board. **Councilman Davis** explained the process, as he said was made clear during the committee meetings, would be to take the Committee's proposed revisions to the Town Board,

and the Town Board would then take under consideration the recommendations made by the Committee and put forth a law for public hearing as they felt was in the best interests of the Town. Mr. Davis began to read the proposed changes. **Planning Board Chair Don Teator** asked, "Freehold is grandfathered in?" to which **Supervisor Macko** stated, "Yes". **Ms. Valicenti** noted she had just scanned the changes, and felt they are the issues which brought concerns to the forefront in the first place. Stated, "You've gone backwards" and that she feels "blindsided and ambushed" and is "not happy with this". **Supervisor Macko** explained it is the Town Board's responsibility to take Committee recommendations and review them and weigh them with the needs of the Town of Greenville. Stated that, "we allow clearcutting and logging, we allow developments, resorts, golf courses, everything else. We must be consistent with our laws." **Ms. Valicenti was displeased and left the meeting.**

Attorney Rappleyea informed the group that there are 3 basic changes now: grandfathering in the Freehold Solar project, increasing the clearcutting restriction from 30% to 50% allowance, and decreasing the setback restriction from neighboring residences from 500 feet to 300 feet. **Councilman Richards** noted that major changes took effect in the review sessions, which drastically affected the project which was already before the Board. Stated, "Cypress Creek is where the litigation liability lies, because of the amount of money they've invested. I agree with Paul, how do we tell people what to do with their own property? I personally don't want them here. But we can't turn back time. We are past the point of no return; I'm not willing to take the chance of litigation which is long and costly." **Ms. Christine Mickelsen** stated that Cypress Creek has pulled projects before, "I hoped that would be the case here."

It was determined that verbiage from sections C4A, D1D, and E14 would be incorporated into section A4.

Alternate Planning Board member and Solar Committee member William Bardel stated, "as a Planning Board member, I will say we've all worked incredibly hard and tried to find an approach fair and balanced to all parties involved. I hope those who aren't happy, realize there are bits and pieces which did not exist in the prior law. We've done the best we can in a fair and balanced approach."

Ms. Mickelsen asked if Freehold Solar was the only project with the go-ahead? To which **Supervisor Macko** stated, "Yes, the others will have to start over." **Councilman Davis** reminded all that the grid won't handle 4 projects. Greenville is looking at a maximum, unless a large upgrade was done, of 3 solar farms. **Ms. Mickelsen** asked if Cypress Creek can be made to comply with decommissioning? To which **Councilman Bear** stated, "Yes, absolutely." **Supervisor Macko** read section C2b and noted halogen-free cables may not be available; stated, "anything we can do to make it as safe as possible, for the community, we will do so." **Councilman Richards** read section C1b, and noted there was previous conversation to decrease the Town's total electric substation capacity to 50%, which would limit the number of projects down to 2 projects. **Councilman Davis** stated he was "OK with 3." **Attorney Rappleyea** added a point to consider related to the process. The Town is free to adopt the law after the Greene County Planning Board meets and reviews the document as was provided to them. If additional big changes are requested, we will need to hold an additional public hearing. **Councilmen Davis and Bear** stated they were "OK with how it is now (at 75%)." **Councilman Davis** noted NYSERDA recommends towns allow 75% of total electric substation capacity for this use.

Ms. Sheryl Baron asked why Freehold is being grandfathered in? **Councilman Richards** stated, "When it comes to litigation process and Freehold, Cypress Creek has been operating in town since 2015, doing every ounce they're required to do. It is my understanding that \$530,000 has been invested. I don't want solar in town, and feel like we're losing some aesthetic value of the town. But we are past the point of no return, they are already operating over 2 years; in light of that, we feel the possibility of litigation occurring with Cypress Creek. I am not willing to risk liability of going into civil litigation with them. In my opinion, that project, there is no going back." **Ms. Baron** asked, "Did it ever occur when it was first investigated that our existing laws were weak and should've been investigated?" **Councilman Richards** replied, "Issue with the area is one thing ~ making changes as required and then having the Board change their minds is another. You have to be fair. Country Estates ~ how many acres were cut there? 140? We should go down the road and tell them they can't cut 20 acres there? There is a loophole which says you can't clear-cut over 30% of the lot designated for solar, and can't build there for 3 years. What's to stop them from pulling the permit, clearcutting 30 acres, then coming back in 3 years to do commercial solar? The committee's proposed draft completely blocked out 3 projects." **Attorney Rappleyea** discussed "substantial right", which needs to be established to be legal. The Courts can say "they've gone far enough and it will be OK to continue" at this point. **Councilman Richards** also stated, "I can also think of many worse things than solar panels to have as neighbors," and, "I don't think it is smart to intentionally block them."

Councilman Davis had issue with the prior law being called "weak". He believes we are very pro-active. Stated Durham is just starting to work on solar. We have 3 farms, on under 60 acres. The Town of Coxsackie has 2,800 acres planned; one project alone has over 2,700 panels.

Ms. Mickelsen was concerned with the law being adhered to; wondered who had authority to give waivers within the law? **Attorney Rappleyea** stated the Planning Board makes decisions and they asked for greater direction. "I strongly doubt with the decommissioning verbiage that the Planning Board will waiver from the black and white as written in the law."

Supervisor Macko brought up C4a changes; **Mr. Teator** stated it sounded like it was now ok to clear-cut 20 acres? **Attorney Rappleyea** replied that it was not valued in acres. **Councilman Richards** reminded all that the law only applies to trees, not to brushy fields. **Attorney Rappleyea** noted even if it was planned on a 100 acre parcel, per C1a, the size cannot be larger than 25 acres.

Mrs. Janet Ricci asked if the builders were working late in the evening, to whom should she call? **Attorney Rappleyea** responded, "Code Enforcement". **Mr. Bardel** asked about section E1a6, pertaining to MSDS, and feels that C2b is related to that. **Attorney Rappleyea** can adapt the verbiage to include both. **Mr. John Reagan** provided a written response for consideration by the Board, and acknowledged the work done by the Town on this matter. He raised concerns about section D1a, and requested the Board consider making it consistent with NYS DEC guidelines of 100 foot setbacks from wetlands and 50 foot setbacks from streams. **Supervisor Macko** said it would be considered.

There being no other comments, Mr. Davis moved to close the public hearing at 6:57 pm, seconded by Mr. Bear. Carried 4 ayes

Supervisor Macko explained a decision will be rendered at the next meeting, to be held on Monday, October 22, 2018 at 7:00 pm.

A SECOND PUBLIC HEARING was held by the Town Board of the Town of Greenville at 7:00 pm in Pioneer Town Hall, to address the Freehold Volunteer Fire Company contract and to receive public comment on the same. Appropriate notice of this hearing was published in the Catskill Daily Mail on Saturday, October 6th and in the Greenville Pioneer on Friday October 12th, as well as on the official signboard at Town Hall as required.

Mr. Davis moved, seconded by Mr. Bear, to open this public hearing at 7:00 pm.
Carried 4 ayes

Supervisor Macko reviewed the proposed contract for years 2019 – 2022. It is the same contract that has been used since January 1966, and reflects a 2% increase each of the 4 years. Stated, "I think it's fair. Freehold Volunteer Fire Company does an outstanding job, as does Greenville." The amount to be raised by taxes in 2019 is \$108,974, in 2020: \$111,153, in 2021: 113,376, and in 2022: \$116,644. Mr. Macko explained that the NYS Comptroller's Office has brought to our attention that the Town must pay the Worker's Comp insurance directly. In the past, the fire company paid for this insurance from the money that we provided to them. The amount to be raised by taxes from those homes within the Freehold Fire District will be sent to the Fire Company in January, minus the amount required to pay for the insurance. A receipt will be included with the payment. **Fire Chief Wade Davis** stated he didn't have a problem with this. **Supervisor Macko** confirmed that, this January, the Town will send \$108,974 minus the Perma insurance money owed. **Code Enforcement Officer and Medusa Volunteer Fire Company President Mark Overbaugh** confirmed this is the required process, and asked if that budget number reflected any increase to reflect the mandated insurance of \$200 per year for interior firefighter cancer coverage? **Chief Davis** replied no, and that there are 6 interior firefighters now, and he will follow up with Supervisor Macko on the number of past interior firefighters to account for. **Supervisor Macko** also requested a copy of their budget for our files, as was required by the Comptroller's Office. **Ms. Anita Zibura** asked if this has anything to do with the 2% tax cap? **Supervisor Macko** replied it was strictly for people within the Freehold Fire Protection District.

There being no other comments,

Mr. Bear moved to close the public hearing at 7:10 pm, seconded by Mr. Davis.
Carried 4 ayes

Mr. Bear moved, seconded by Mr. Richards, to approve the Freehold Volunteer Fire Company contract for 2019-2022, with the stipulation that a copy of their budget is received.
Carried 4 ayes

Continuing on with the regular monthly meeting;

Mr. Bear moved to accept the Clerk's minutes of September 17, 2018 and October 1, 2018, seconded by Mr. Richards. Carried 4 ayes

Oral and/or written reports were received from the Rescue Squad, Highway, Buildings and Grounds, Code, Assessing, Clerk/Tax, Dog Control, Sewer and Water departments, and Planning and Zoning Boards.

-Greenville Rescue Squad President Ted Nugent introduced the new GRS Chief, Matthew Marlow, who provided a written and oral report. He can be reached Monday through Friday from 8:00 – 2:00 at the ambulance building. A warm welcome was offered by Councilmen Bear and Davis. Conversation went on to include budget talk; GRS Vice President Cliff Powell will meet with Mr. Macko to address potential 1 year and 4 year budgets.

-Highway Superintendent Terry Williams stated paving and shoulder work was complete on Scutt and Highland Roads. The employees are prepping snowplows currently, and salt and sand are arriving for the winter.

-Building and Grounds Supervisor P. Leroy Bear reported on work done for pre and post clean-up on Greenville Day, leaf-vacuuming, and the new building which is going up at the sewer plant site.

-Code Enforcement Officer Mark Overbaugh provided a written and oral report. Tractor Supply is open, with a temporary Certificate of Occupancy, which is good for 30 day periods of time. Issues still exist with the NYSDOH, SWPPP permits, and related water issues. Supervisor Macko clarified that the problem is not on our end, it is with Bohler Engineering ~ to which Mr. Overbaugh agreed. Mr. Overbaugh noted that today he received 8 hours of education in Albany, which fulfilled his annual educational requirements.

-Supervisor Macko offered the sewer report. Stated the pump stations seem to be working as expected. The Hill Street station is now cleaned biannually, which prevents many problems. "The system is working well."

-Water Superintendent P. Leroy Bear verbally offered the water report and provided the usual monthly documentation. All annual testing is complete. The department is almost done with flushing. There were small issues on Hill Street and in town, but otherwise all is 'in line'. It was noted that the cost to do business with the water billing company will double in April 2019, but they will offer additional services. Mr. Bear feels they do a good job, and as there has not been an increase since we started with them in 2012, it is well worth the price. No further discussion occurred at this time.

-Councilman Bear offered the recycling report. He feels we must do something with the area of broken concrete, as previously discussed last month. Maintenance and Grounds Supervisor Leroy Bear replied 'we' don't have the ability to do anything. He is looking into Spancrete. Supervisor Macko will check for contacts and follow up on this issue. Per-diem Operator Paul Augstein questioned if part of the problem there was the wall that the span was set upon. Discussion on proper repair followed.

-Supervisor Macko read a written Assessor's report.

-Planning Board Chair Don Teator reported on activities for the Planning Board. They are working on a 2 lot subdivision with driveway issues, noted a redemption center may go in the former Siemag building in Norton Hill, and the Sewing Room may become a restaurant/brewery. Supervisor Macko noted that review still needs to occur on the subdivision law, as well as the road use law. After January 1st, meetings for the above will be scheduled.

-DCO Rosa reported on billing concerns with the Columbia Greene Humane Society as they relate to unredeemed but licensed dogs. Other Towns have made specific provisions in their laws so that legally licensed owners are held responsible for their animals, and perhaps it is time to revisit our Local Law. Supervisor Macko will review the law with Attorney Rappleyea and prepare to set up for a public hearing to address any changes.

-Supervisor Macko reported on a very successful Greenville Day, and thanked the Maintenance Department, Volunteers, and Concession vendors for contributing to this event.

New business discussed at 7:36 pm:

-A letter was received from the Greenville Girl Scouts Service Unit 115 leaders Janelle Bucci and Diane Therrien Smith. They are requesting permission to use a room upstairs in Town Hall for the purpose of a monthly adult leader meeting, where they can have a space dedicated just for their use where items can be both on display and securely stored. Supervisor Macko noted he first offered this space to the Greene County Sheriff Department for their investigators. Councilman Davis agrees that he doesn't think this space can be offered exclusively. Mr. Macko suggested using the North Barn. At this time, it was agreed that the space cannot be offered to the Girl Scout Troop.

-A thank you was received from Directors at the Greene County Council on the Arts for the Town of Greenville's 2018 contribution and support of the SPROUTS program.

-The Greenville Library Board of Trustees has requested Kathie Quackenbush and Margaret Finch each be reappointed to their positions on that Board.

Mr. Davis moved, seconded by Mr. Bear, to reappoint Kathie Quackenbush and Margaret Finch as Trustees on the Greenville Library Board for the term January 1, 2019 to December 31, 2023.

Carried 4 ayes

-Supervisor Macko discussed a project of the Cornell Cooperative Extension involving creating a natural resources inventory. A review session will be held on October 24th at 6:30 pm in Acra where the public is invited and encouraged to attend.

-Supervisor Macko noted that the Stevens Hill Farm on CR 26 is under review to be identified on the NYS Register of Historic Places.

-Supervisor Macko also extended an invitation to attend the annual Greene County Honor a Vet Memorial Ceremony, to be held on November 3, 2018 at 10:00 am at the Catskill Point Warehouse. This year, Seaman First Class Alfred Van Schaack, Jr. will be honored.

-Supervisor Macko discussed the NYS requirement that all public employers have a sexual harassment policy in effect. He found a 'boilerplate' NYS policy, 8 pages, and adapted it as pertinent. Clerk-Collector Park noted that the Town approved the draft employee manual in 2007, which includes a 1 1/2 page sexual harassment section, and would the Board like to consider that one as it may be more appropriate? Attorney Rappleyea noted NYS required this policy be in effect by October 7th, so it was very time sensitive. Councilman Davis stated he had reviewed the policy and felt it was acceptable;

Mr. Davis moved, seconded by Mr. Bear, to accept the New York State's Sexual Harassment Policy for All Employers in New York State as the Town of Greenville policy.

Carried 4 ayes

-The Budget Hearing needs to be scheduled;

Mr. Bear moved, seconded by Mr. Davis, to conduct the 2019 Budget Hearing on Wednesday, November 7, 2018 at 6:00 pm in Pioneer Town Hall.

Carried 4 ayes

-Supervisor Macko reported that the Old Timer's Christmas party has been scheduled for Sunday, December 2nd at 12 noon at the Greenville High School.

Supervisor Macko opened the meeting for public comments and questions at 7:46

pm: Attorney Rappleyea addressed the need for a SEQR long form in order to enact a Local Law amending Town Zoning Law as it relates to Commercial Solar Facilities. Part 2: Identification of Potential Project Impacts was read by Attorney Rappleyea in its entirety. As all responses were 'no', he recommends declaring this action to have a negative impact.

Councilman Davis moved, seconded by Councilman Bear, to declare that this impact should be considered a negative declaration.

Carried 4 ayes

Attorney Rappleyea noted that once comments are received back from the Greene County Planning Board, the Town will be free to take action on this matter as desired.

As there are no public comments, Mr. Davis moved to enter executive session at 7:54 pm, seconded by Mr. Richards, to discuss the proposed acquisition/sale/lease of real property when publicity might affect value. Mr. Travis Smigel and Mr. Leroy Bear were invited to participate.

Carried 4 ayes

Mr. Davis moved to return to regular session at 8:20 pm, seconded by Mr. Macko.

Carried 4 ayes

No motions were made in executive session.

October 22, 2018

A special meeting of the Town Board of the Town of Greenville began on October 22, 2018 at 7:05 pm at Pioneer Hall for the purpose of conducting a budget workshop.

Those present: Supervisor Macko and Councilmen Bensen and Davis, as well as the following Department Heads: Code Enforcement Officer Mark Overbaugh. Also here were Greenville Rescue Squad representatives Ted Nugent, Cliff Powell III, and Fran Sickles, Solar Zoning Review Committee members Barbara Valicenti and William Bardel, Cypress Creek representative John Reagan, and 5 interested guests.

Those absent: Councilmen Bear and Richards, and Attorney Rappleyea.

Supervisor Macko opened the meeting with the Pledge of Allegiance.

Initial discussion at this workshop related to the Solar Zoning Law. A public hearing was conducted on October 15, 2018; no motions were made that day. Councilman Davis stated he has spoken with all of the Town Board members, and feels that there was panic last week due to fears of litigation. He recommends grandfathering in the Freehold solar project, and returning to the recommended plan as devised by the Solar Zoning Committee. Discussion ensued. Councilmen Bensen clarified "that 'grandfathering' means they (Freehold) can do the project but they have to comply with the provisions in this law, including the MSDS sheets, heavy metal restrictions, but not with clearcutting or setbacks. But it will be fairly close." The Greene County Planning Board has reviewed the draft law and finds it acceptable. Per message of Attorney Rappleyea, as no comments were offered, the town is free to adopt the law.

Mr. Davis moved, seconded by Mr. Bensen, to approve Local Law #2 of 2018: Enacting Amendment to the Town Zoning Law Regulating Solar Facilities, going back to the Solar Committee's recommendations bypassing C4a, D1d, and requiring a MSDS submission, and ensuring compliance with heavy metal regulations, and the decommissioning requirements.

Moving on, at 7:20 pm Supervisor Macko noted receipt of notice as required by law from the Town of Cossackie, who will be conducting a public hearing related to regulation and approval standards for solar collection systems. This is scheduled for Tuesday, November 13th at 7:00 pm in their Town Hall.

A discussion on storage capabilities for alternative energy occurred. Supervisor Macko feels that we will be holding additional meetings by this spring to address this need.

The 'dog law', Local Law #3 of 2015, was provided for the Councilmen with a request to review the document for the purpose of updating the law. Discussion continued regarding the management of dogs, housing, fees, shared services, and NYS Ag & Market requirements. This will be revisited at an upcoming meeting.

At 7:30 pm, the shared services/inter-municipal agreement between the Town and the Greenville Fire District was addressed. Supervisor Macko stated he "jumped the gun" sending a notice of termination of said agreement to the Fire District as there was no public record of the conversation to sever the agreement. Councilman Bensen inquired what the shared service was, and feels it can't be all one way. Supervisor Macko suggested the highway department could make a pass through their lot in the early

morning hours to open up the driveway, then having the maintenance department go in afterwards to clean it up. He suggested negotiating this with Highway Superintendent Williams. Fire Commissioner Ted Nugent replied their biggest concern was that the cost of hiring for snow removal was not planned into their 2019 budget because there was no indication that the agreement would be terminated. Councilman Davis noted that last year, it put a strain on the maintenance department. Clerk-Collector Park stated that department, just a few years ago, was twice the size as it is now. Mr. Nugent feels the shared service is a benefit to the taxpayers and to the state. Councilman Bensen argued that the Fire District budget didn't decrease *at all* during the agreement. This issue will be explored further next month, as neither Maintenance Supervisor Bear nor Highway Superintendent Williams were present to offer their comments.

At 7:40 pm, Supervisor Macko relayed news that the State Legislature approved release of the funding from DASNY in the amount of \$100,000, from the grant the town has been waiting 10 years to arrive. Once obtained, that money will be reserved for replenishing the General Fund Reserve balance, and will not be earmarked for another use. Mr. Cliff Powell, of the Greenville Fire District, suggested the Maintenance Department would benefit from having both maintenance department pick-up trucks be snowplow capable.

Clerk-Collector Park raised concerns after the last meeting with the dates on the contract with the Freehold Volunteer Fire Company. It was approved stating payments are to be made "on the 1st of January of the year for which it is paid". This simply is not possible by that date as the tax collection process doesn't start until January 2nd. After received, the taxes collected are forwarded to the Town's Bookkeeper regularly, and satisfaction of the levy is complete by the 31st of January each year. The Fire Companies and Rescue Squad payments are the first of all the funds to be made, regardless.

Mr. Davis moved, seconded by Mr. Bensen, that the dates on the Freehold Volunteer Fire Company contract signed on October 15, 2018 be changed to reflect a payment due date of February 1st of each year of the contract.

Carried 3 ayes

Continued review of the 2019 tentative budget began at 7:45 pm. Supervisor Macko explained he assumed the unexpended balance would be on par versus last year; Highway, Water and Sewer values are fine, but there is not enough fund balance in the General Fund to allow for adjustment towards the 2019 budget. That being said, Mr. Macko has removed raises for Town Hall employees and stated this mirrors last year's budget more or less. With only \$10,535 taken as unexpended balance towards the 2019 budget, the 2019 amount to be raised by taxes equals \$1,890,528, or a \$157,923 increase.

Each line was reviewed. The Town Clerk-Collector's personal services line pertaining to deputies was cut by \$5,000 from the usual and already previously reduced line of \$7,000, leaving only \$2,000 for deputy salaries. Lengthy discussion followed; it was agreed upon to decrease this line to \$6,000, which would cover the amount of time historically worked by the Deputy Clerk-Collector and Deputy Tax Collector, annually. A defense of this Clerk-Collector's small use of Deputies as compared to neighboring towns as well as discussion of how money is freely spent within this Town Hall and how personnel are managed, occurred. It was questioned why no other Department Heads were present for the second meeting in a row to answer questions regarding their submitted budgets? This writer expressed disappointment that a budget cut to her line was proposed out of the blue, instead of addressing the issue prior to the meeting. It was noted that this writer's line was the only line relating to active salary that was proposed as a cut.

The Park line in Culture-Recreation was cut, as "it was not being used. (Mr. Macko) hates to cut it too much in case it is needed". Clerk-Collector Park questioned if the vandalism was still occurring at Vanderbilt Park, and why isn't surveillance being considered? CEO Overbaugh asked if there have been any arrests stemming from these incidents on Town of Greenville property. Supervisor Macko acknowledged the vandalism has continued, and he was not aware of any follow up arrests.

The Roller Skating/Youth line was cut to accommodate 3 weekends only. The Adult Recreation line was increased by \$100. Community Partners member William Bardel graciously offered thanks for the assistance towards the annual fireworks display at Greenville Day, but felt that the group would be willing to forgo the donation this year, if it helped. No comments were received from the Board.

Supervisor Macko discussed the revenue page; the Greene County Sheriff's Office (GCSO) is considering utilizing space on the second level of town hall, and there remains the possibility of revenue there.

Of the \$75,000 in unexpended fund balance for the General Fund, Supervisor Macko recommends \$10,535 be taken towards the 2019 budget.

The Highway contractual line for snow removal was increased by \$4,000; employee benefits decreased.

Supervisor Macko noted the hospital and medical line under employee benefits for the Water budget more than doubled, from \$12,000 to \$29,000, as upon his retirement from the Maintenance Department in March, Water Superintendent Leroy Bear wishes to remain as the Water Superintendent and is seeking insurance coverage from the Town.

The library budget was addressed; Supervisor Macko confirmed with the NYS Association of Towns that the Town Board is authorized to amend the library's proposed budget. He said to align with the tax cap, their budget should be \$111,000, and that they requested an amount \$2,159 over the cap. Councilman Davis agreed it should be limited to a 2% increase. Director Flach has requested a 61 cent per hour raise, and the various clerks were put in for between a cut of 35 cents to a raise of 50 cents per hour. Clerk-Collector Park questioned why this was even being calculated, if no raises were being given to Town of Greenville employees this year. Councilman Davis stated, "We, as a Town Board, have control of the total budget, but I'm not sure if we have a say in what salary the employees are paid." Councilman Bensen inquired as to if they had anyone at minimum wage; Supervisor Macko was not sure what the 2019 minimum wage was. Councilman Davis feels their "budget increase needs to be increased only by 2% to align with the tax cap." Stated, "It isn't fair for some to have raises and not others, but we may not have a say in that." CEO Overbaugh commented, "Fair is fair, zero percent for all departments, in all 3 buildings (town hall, highway, library); the Town Board's responsibility is to treat all town employees the same." This line item was adjusted.

Greenville Fire line was per their budget. The Freehold Fire line was per approved contract. Joe Meyers, Sewer Operator, had an increase based on the Consumer Price Index and was per contract.

These changes reflect a tax increase for 2019 in the amount of .549734/\$1,000 assessed value; a home assessed at \$100,000 will see an increase of \$54.97 in their taxes. The tax rate increase is 8.06268%.

Mr. Davis moved, seconded by Mr. Bensen, effective immediately and through December 31, 2018, there is to be no unnecessary spending, and all spending must be approved by the Supervisor.

Carried 3 ayes, 2 absent

Supervisor Macko commented that a quarter million has been spent on the local rescue squad services, and it is money well spent ~ but that's where the fund balance in General went. Mark Overbaugh commented the town "can't keep adding ~ sidewalks, sewer, water, parks, all arts matter ~ it all takes manpower. You'll double your manpower. It all costs." Councilman Davis agreed. Stated, "It's a vicious cycle. We are moving ahead, and it all costs."

Information was provided to the Board regarding creating an ambulance district. Supervisor Macko feels that the Town could better manage the tax cap if the ambulance and EMS costs were separated into its own district.

Supervisor Macko called this budget a no-fluff budget. He asked if it was ready to be adopted as the preliminary budget. Councilman Bensen stated the library budget needed adjusting first. With the reduction in that budget line, the taxes are still increased by .54194518; a 7.94% increase.

At 8:43 pm, Mr. Bensen moved to adopt the preliminary budget; Councilman Davis was not yet prepared to do so. CEO Overbaugh stated, and Supervisor Macko acknowledged, that if the GCSO rents space upstairs, a new bathroom would have to be placed. Regardless of it that happens, a properly functioning bathroom is required in this building; money is spent regularly on repairs which do not seem to solve the problem. Supervisor Macko replied, "In April, we'll fix it".

Mr. Macko noted we are \$123,000 over the 2% tax cap. Councilman Davis noted medical insurance is the big one, and we ran through our reserves... Councilman Bensen stated that the Governor's past 0.6% cap did not help matters. Mr. Davis would like to get the number down \$40 - 50 thousand; Mr. Bensen said to use fund balance. Supervisor Macko disagreed. Mr. Davis said we'd have to bite the bullet; he hates to pick away at individual lines. Mr. Bensen feels that if it's below an 8% increase, that is fine.

Mr. Bensen moved, seconded by Mr. Davis, to approve the preliminary budget with the library appropriation line decreased by \$2,159.

Carried 3 ayes, 2 absent

This reflects a tax rate of \$7.35957 per \$1,000 assessed value, or an increase over last year of .541324 per \$1,000, or 7.93%.

Conversation continued regarding the line item increase for the Rescue Squad. Mr. Powell answered that the Board had already approved it. Mr. Nugent replied that they don't have to provide a budget; Councilman Bensen replied that we don't have to contract with them. In question was the \$60,000 building expense line. Mr. Nugent stated their intent was to invest in the Town, and if that is what the Town desired, they would be looking into investing in a facility of their own, in the future. Councilman Davis responded, "We are paying dearly, but the service is exceptional." Transparency was requested.

A budget hearing has already been scheduled for Wednesday, November 7, 2018 at 6:00 pm in Pioneer Town Hall.

There being no further business, Mr. Davis moved to adjourn at 9:20 pm, seconded by Mr. Bensen.

A special meeting of the Town Board of the Town of Greenville was held for the purpose of first conducting a public hearing regarding the 2.00% tax cap followed by a budget hearing regarding the proposed 2019 budget on Wednesday, November 7, 2017, at 6:00 pm at Pioneer Hall. Appropriate notice of the budget hearing was published in an official newspaper, the Greenville Pioneer, on October 26, 2018, and of the tax cap override in the Daily Mail on October 27, 2018.

Supervisor Macko opened the meeting with the Pledge of Allegiance. **Mr. Bear moved to open this hearing at 7:00 pm**, seconded by Mr. Richards. Carried 3 ayes, 2 absent at this time

Supervisor Macko reviewed the budget highlights and factors contributing to the need to consider an override of the 2019 imposed tax cap. The General Fund spending is up \$21,000 from last year's budget. The increase that was presented is approximately 53 cents per \$1,000 assessed value.

Mr. Macko opened the hearing for any public comments or questions at 6:02 pm: as no other questions were raised, Code Enforcement Officer Mark Overbaugh asked how that increase compared to the Greene County budget? Supervisor Macko was not aware of definitive information from the County, but continued to explain that at the town level, an order was enacted last month for a freeze on unnecessary spending and any overtime, excluding public safety issues, to continue through 2019. No raises would be offered in 2019. The fund balance needs to be built back up; last year over \$125,000 was used from reserves, and this year only \$10,535 will be taken from the reserves to offset the next budget. A quarter million was spent over the past 3 years on the ambulance service, which was a "much needed 24/7 operation ~ but it costs". *Councilman Davis arrived at 6:05 pm*. Code Enforcement Officer Overbaugh reminded the Board of anticipated revenues from several sewer hook ups which were not completed during the no-cost grace period, as well as building department fees related to the commercial solar installations.

All persons desiring to be heard, having been heard, Mr. Bear moved to close the public hearing at 6:10 pm, seconded by Mr. Richards. Carried 4 ayes, 1 absent

Mr. Bear moved to adopt Local Law #3 of 2018, to override the tax levy limit established in GML §3-c, seconded by Mr. Davis. Carried 4 ayes, 1 absent

Mr. Davis moved to open the 2019 budget hearing at 6:11 pm, seconded by Mr. Bear. Supervisor Macko repeated that this is a no-fluff budget. The proposed tax levy is \$1,887,073, and reflects an increase of .5362 per \$1,000 assessed value, which is a 7.86% increase. A home with an assessed value of \$100,000 will pay an additional \$53.62 on their 2019 tax bill, compared to 2018. He stated the increase is not from overspending, rather was a problem related to the imposed tax cap. Fund balances have been used in recent years to make the budget work, and the money just isn't there this year to apply any to next year's budget.

Supervisor Macko relayed that a shared service agreement has been discussed with the Greene County Sheriff's Office in which they will occupy the upstairs level of Town Hall to use as office space, compensating the Town \$3,600 per year to cover the cost of utilities. They also have agreed to provide 2 hours per week of security for the Court when it is in session. This equates to a shared service value of \$10,464. Discussion occurred regarding relocating a bathroom as well as installing locks on the doors which provide access to the remainder of Town Hall office space. Clerk-Collector Park also requested the front door of Town Hall remain locked off hours when the upstairs office is in use, for security measures. CEO Overbaugh inquired as to whom will pay for the necessary fixtures in creating a handicapped accessible bathroom, and believes the County should be asked to do so as part of the usage agreement. Councilman Richards noted it can't hurt to ask, that he believes the County may be footing the bill in Coxsackie for renovations to the building they will be using there. Councilman Bear believes the Town should cover the expense, that it is taxpayer money one way or another. Supervisor Macko is receptive to asking the County to pay for the work done in preparing a bathroom, as the main level single bathroom currently in use here does not work properly and once the authorities are upstairs, the town employees will not have access to that area. The shared service agreement will be drawn up and reviewed, and will include the safety measures discussed as well as the renovation plans.

CEO Overbaugh again addressed commercial solar fees for building permits as well as fees to be collected for the remaining sewer hook ups, and noted that these fees could help offset the increase in this year's levy. As these numbers were merely anticipated and not guaranteed, Supervisor Macko thought the 2019 budget process was too far along now to make adjustments, and that any revenues that may come in will certainly help next year's budget process.

Mr. Macko again asked for any public comments or questions at 6:28 pm; none spoke in favor of or against the budget as presented.

All persons desiring to be heard, having been heard, Mr. Bear moved to close the public hearing at 6:28 pm, seconded by Mr. Richards. Carried 4 ayes, 1 absent

Mr. Bear moved to adopt the 2019 budget as presented with the amount to be raised by taxes \$1,887,073, which is \$7.354520 per \$1,000 assessed value, which equals a 7.86% increase for the 2019 budget. Seconded by Mr. Davis.

Carried 4 ayes, 1 absent

The solar fee conversation continued as it is imperative a fee be established before a building permit is received by the Building Department to review. The fees can be based on square footage of the panels, cost of installation, or wattage. A measure of the square footage is

considered the most accurate and concrete number to use. Much research has been done as to how some other towns this. Proposed options will be further discussed at the regular November meeting. All believe the fees will help to restore some of the fund balances.

Supervisor Macko stated Attorney Rappleyea will have a draft agreement for shared services with the Greene County Sheriff's Office, as well as with the Greenville Volunteer Fire District, prepared for our next meeting. Also on the next agenda will be discussion of establishing the Greenville Rescue Squad as an Emergency Services Tax District, which will aid in managing future budgets with any tax cap imposed.

There being no further business, Mr. Macko moved to adjourn at 6:38 pm.

Governor Andrew M. Cuomo today announced \$41.5 million in grants to support 20 critical municipal water infrastructure projects in the Capital Region. This funding represents \$89.4 million in taxpayer savings and supports the creation of nearly 2,000 jobs. These grants are funded through the state's highly successful Water Infrastructure Improvement Act and Intermunicipal Grant programs.

"Investing in our state's water infrastructure is critical to regional growth and prosperity and maintaining safe, healthy communities," **Governor Cuomo said.** "By improving our water infrastructure, we are protecting our natural resources, laying the groundwork for future prosperity and helping to create a stronger, healthier, New York for all."

"It's critical that we ensure our drinking water is free of contaminants and safe for all New Yorkers," said Lieutenant Governor Kathy Hochul. "This investment in grants for infrastructure improvements in the Capital Region will address needs to enhance and protect water quality, and also help to create more than 1,000 jobs in the area. We want to make sure that

communities have the resources they need to make upgrades to their water treatment systems and ensure the health and safety of residents."

The Governor's Clean Water Infrastructure Act of 2017 dedicated \$2.5 billion for water quality protection across New York. Today's announcement is part of a statewide total of \$270 million in grants being awarded to communities, including over \$19 million to support projects that address cyanotoxins associated with harmful algal blooms (HABS), and previously announced grants totaling \$15 million for projects addressing emerging contaminants such as PFOA, PFOS, and 1,4 dioxane.

To date, \$750 million in Water Infrastructure Improvement Act and Intermunicipal Grant funding supports nearly \$2.65 billion in total project costs for vital drinking and wastewater infrastructure projects statewide. Combined with zero- or low-interest financings through the State Environmental Facilities Corporation, New York taxpayers will save nearly \$1.8 billion. Furthermore, these projects are expected to support more than 47,000 jobs in the construction, supplier and service sectors.


We have reviewed the most recently revised plans and specifications submitted for the Greenville water main extension to serve the new Tractor Supply building location on Route 32. These plans were received on October 29, 2018. We note that construction was completed prior to receiving plan approval from the Department of Health and we therefore consider these plans as as-built drawings. We find that the information submitted for the 192-foot water main extension, 6-inch Magnum 20(x) double check valve (DCV) on the building sprinkler supply line and 1-inch Watts LF-909QTS reduced pressure zone backflow prevention device (RPZ) acceptable with the following conditions.

1. That by November 16, 2018 the DCV and RPZ must be tested by a certified backflow prevention device tester and a completed form DOH-1013 (copy enclosed) must be provided to the Town of Greenville Water Department and this office.

By copy of this letter we are reminding the Town of Greenville that in accordance with Subpart 5-1 Section 5-1.31 they will need to make sure these two backflow prevention devices are tested at least annually by a certified backflow prevention device tester.

We are retaining one copy of the accepted plans and returning the other copies to you. If you have any questions, do not hesitate to contact this office at 607-432-3911.



1 Year Ambulance Contract

This Agreement made this 19th day of November 2018, Between the Town of Greenville a Municipality located in the County of Greene and existing under the laws of the State of New York. Hereinafter called the Town and the Greenville Rescue Squad Inc., a non-for-profit Emergency Medical Service organization with its principal place of business located in the Town of Greenville, hereinafter called the Rescue Squad.

Witnesseth:

Whereas, there is located within the boundaries of the Town of Greenville no hospital nor hospital ambulance and

Whereas, the Town is desirous of having an ambulance service available for its residents, and

Whereas, the Rescue Squad is capable of and willing to provide such ambulance services.

Now Therefore, in consideration of the sum of \$277,500 for the year of 2019. Paid in equal quarterly payments on the fifteenth day of February, April, July, and October of each year of the contract. (2019 quarterly payment would be \$69,375)

1. The Rescue Squad shall provide ambulance service to the Town during the period of January 1, 2019, through December 31, 2019. The emergency medical services shall be provided seven (7) days a week, twenty- four (24) hours per day.
2. Such ambulance services shall be provided at any and all places and locations within the geographical boundaries of the Town of Greenville.
3. This agreement shall not limit the rights of the Rescue Squad to provide emergency medical services to individuals not within the geographic boundaries of the Town of Greenville. Services shall be available to the Town of Greenville at all times, however, in the event the Rescue Squad allows its ambulance to leave the Town of Greenville, it shall make alternative arrangements to service the Town of Greenville during the Absence of its equipment (Under mutual aid agreement).
4. The Rescue Squad agrees to continue its third party billing system, consistent with the efforts of other similar Emergency Medical Services in the State of New York.
5. The parties agree that this agreement may be terminated with ^{three}~~six~~ (3) month advance written notice and all remaining funds due hereunder shall not be paid. *PJM*







Then we turned to the last major part of the program.

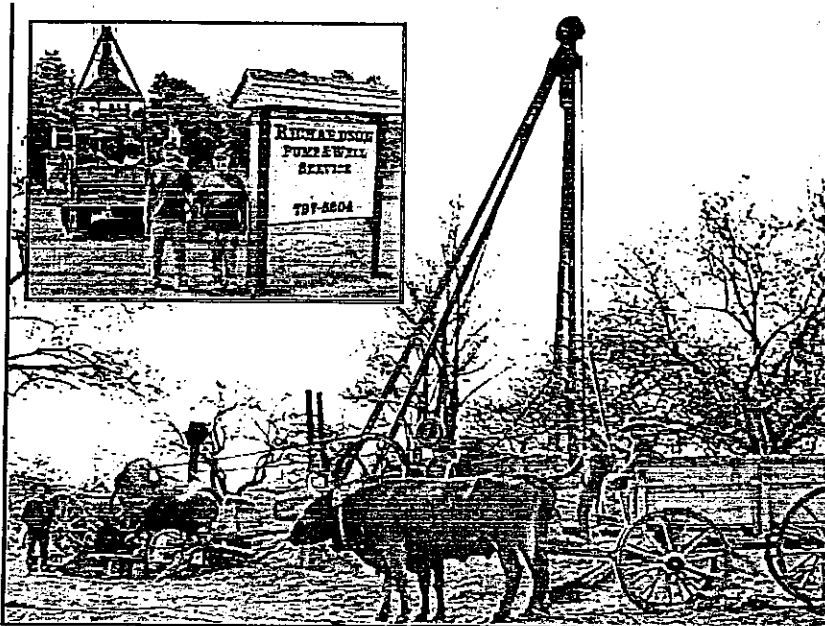
With a calendar in hand, we perused page by page. As always, I hope a worthy calendar has been assembled.

The Big Note: the 2020 Recognition
