Motion made to open the Public Hearing for Tryland, Preisner & Gorch made by Don Teator. Seconded by Ken Elsbree. All in favor: 4, Opposed: 0, motion carried.

Tryland, Preisner & Gorch- Subdivision @ 158 Highland Rd Tax Map #25.00-2-24

Mr. Harvey was present to present the proposed plans for the property to be divided into "2" lots. One would be 2.02 and the other would be 5.37 acres. Total acreage is 7.3 acres and the property is zoned LDR. There would be the allowed road frontage of 150ft. The Board and the surveyor reviewed the maps presented; since last month's meeting there were "2" notes added to new surveyed maps (note location plans). All paperwork is in order at this time.

Motion made to approve the minor "2" lot subdivision for Tryland, Preisner, & Gorch at 158 Highland Rd; with the condition that The Board be presented with acceptable Mylar maps that will show the "notes location plan" made by Ken Elsbree. Seconded by Bud Bear. All in favor: 4, Opposed: 0, motion carried.

Albert Vedder- Subdivision @ 710 Old Plank Rd Tax Map #23.00-5-25.11

Mr. Vedder was approved for a minor "3" lot subdivision on March 24, 2015. Tonight Martin Schmidt presented the Board with new/corrected surveyed maps. During the initial survey there was snow on the ground, which prevented Martin from taking into account a rock wall on the property. A new survey was completed and new maps drawn up. When the property lines were redone one of the divided lots (lot 1) was shorted 1.46 acres. Tal is aware of the situation and all paperwork is in order properly now.

Motion made to approve the revised maps in the Vedder subdivision showing that the South side of Lot 1 in the Town of Durham, will increase in size by 1.46 acres because of a stonewall missed during the initial survey made by Ken Elsbree. Seconded by Don Teator. All in favor: 4, Opposed: 0, motion carried.
