TOWN BOARD MEETING January 16th, 2023 7:00pm

The regularly scheduled monthly meeting of the Town Board of the Town of Greenville was held on Monday January 16th, 2023 at 7:00pm at Pioneer Hall. Deputy Supervisor Bensen opened the meeting with the Pledge of Allegiance at 7:00pm.

Three Board members were present, Supervisor Macko and Councilman Richards were absent. Attorney Tal Rappleyea was present as well as department heads: Water Superintendent Renee Hamilton, Highway Superintendent Mike Dudley, Planning Board Chair Don Teator, CEO Mark Overbaugh and Maintenance Supervisor Tim Fitzgerald. Travis Smigel from Delaware Engineering and District 4 County Legislator Greg Davis were present along with 13 in person guests. Supervisor Macko was present as a guest via teleconference.

Meeting Minutes from: the regularly scheduled monthly meeting on December 19th, 2022 at 7pm and the special meeting to adopt the Organizational Resolutions on January 2nd, 2023 were put up for approval. *Councilman VonAtzingen motioned, seconded by Councilman Bear to approve the meeting minutes for the December 19, 2022 monthly meeting as well as the special meeting to adopt the Organizational Resolutions minutes. <i>Carried 3 ayes*

Old Business

Monthly department reports were given for Rescue, Highway, Building and Grounds, Code Enforcement, Sewer, Water, Recycling, Planning Board and Beautification.

Rescue – Chief of Operations Matt Marlow read of the yearly report for 2022 (attached). Mr. Marlow clarified for the Board that this was ~200 more calls than 2021.

Highway – Highway Superintendent Mike Dudley reported that there had been a lot of ice and flooding over the last month. They have been trying to salt to keep up with it as best as they can.

Building & Grounds – Maintenance Supervisor Tim Fitzgerald reported that they are maintaining their winter routine. They do daily checks of the heat in each building and collect garbage at the park every few days. They removed the lights and trees in the park and have been painting in the Court, as well as updating some trim in the Clerk's office.

Code Enforcement – CEO Mark Overbaugh read his monthly report (attached).

Sewer – Water Superintendent Renee Hamilton reported that the sewer plant has been running well and Councilman Bensen reported that the generator is back up and running.

Water – Water Superintendent Renee Hamilton read off the monthly usage/treatment and reported that they have well 3 hooked up because the meter failed. Leroy reported that the capital project is still moving along and has submitted a proposal for meter part replacements. The furnace at the water plant also needs replacing. *Councilman Bear motioned, seconded by Councilman Von Atzingen to make*

the emergency purchase of a new furnace for the water plant dispensing normal procurement policy for up to \$5,000.00. Carried 3 ayes

Recycling – Things are running smoothly, still waiting for dumpster for tire storage.

Assessor – Exemption applications are due March 1, 2023.

Planning Board – Planning Board Chair Don Teator reported no new news as there was no January Planning Board meeting.

Beautification – Bill Von Atzingen reported that he is working on gathering 3 estimates for the necessary repairs to Prevost Hall.

District #4 County Legislator Greg Davis reported that the county is working on a long-term plan for continuing their 0% tax increase, a Public Hearing is scheduled to discuss the adoption of a law for volunteer firefighter exemption. Mr. Davis also reported that the Town of Greenville's resolution to accept ARPA funding from the County is on their agenda for their next meeting.

New Business

Colin Augstein – came before the Board with sign examples for his progressing Eagle Scout project.

Councilman Bear motioned, seconded by Councilman Von Atzingen to use the bottom left sign example provided.
